In uitvoering van het openbare visserijbeleid stellen de Provinciale Visserijcommissies jaarlijks herbepotingsplannen op. De herbepotingsplannen omvatten per vissoort de jaarlijkse uitzetlocaties en hoeveelheid pootvis die uitgezet wordt op die plaatsen.
