In order to ensure continuity of deliveries and avoid operational consequences, it is necessary to implement the procurement with a reduced tender deadline. The need cannot be taken care of within ordinary deadlines. The procurement is for a temporary contract for a limited duration, until a new government joint agreement is in place.
