Justification for direct award: The contract can be provided only by a particular economic operator because of an absence of competition for technical reasons

Other justification: In accordance with Article 71(1)(2)(b) of the Law on Public Procurement, services may be procured through a negotiated procedure without prior publication where the services can be provided only by a particular supplier due to the absence of competition for technical reasons. The LinkedIn platform (hereinafter – the Platform) is used by millions of people worldwide and is a highly popular and widely recognized tool. There are no alternative systems globally that are equivalent to this Platform. Firstly, it serves as a communication tool for informing the public about processes taking place within Ignitis Group. Secondly, the Platform contains a database of specialists and professionals from various fields in one place. Other platforms offer either specialist databases or communication capabilities, but not both; therefore, they are not equivalent to the LinkedIn Platform. It is planned to procure services of the “LinkedIn” Platform, including employee search, publication of job advertisements, and communication. These services are integrated and operate within a unified technological environment, enabling the consistent execution of talent attraction and communication activities within a single system. The aforementioned services are provided through the Platform, which is owned and operated by LinkedIn Ireland Unlimited Company, and access to its functionalities and user data is granted exclusively by this service provider. For this reason, other market participants do not have the technical capability to offer equivalent services or provide access to the same Platform. The Platform operates internationally and enables access to candidate profiles and professional information across different countries and markets. It allows targeted candidate searches based on various criteria, including professional field, experience, geographical location, and other parameters, without being limited to specific specializations or sectors. The Platform is used to search for specialists in various fields, including lawyers, engineers, finance professionals, and other experts. Other platforms typically offer only individual functions, such as job posting, candidate databases, or communication features, but do not provide the full set of required functionalities within a

single integrated, internationally operating environment. Therefore, such solutions cannot be considered equivalent to the planned procurement object from either a functional or technical perspective. It should also be noted that Article 72(1) of the Law on Public Procurement provides that an international procurement through a negotiated procedure without prior publication may be initiated only after obtaining the consent of the Public Procurement Office or after publishing a voluntary ex ante transparency notice. The contracting authority will publish a voluntary ex ante transparency notice as specified in Clause 19 of the Special Procurement Conditions.
