The Contractor that is ranked second will only be required if the first ranked Contractor cannot fully meet all of the Contracting Authority's requirements. If the first ranked Contractor notifies Sefton Council that it is no longer able to supply under the Framework Agreement, or if the first ranked Contractor is unable to fulfil a Contracting Authority's full requirements under a Call-Off Order, the Contracting Authority may

Then place an order directly with the second ranked Contractor on the Framework Agreement. Based on the nature of the requirement Sefton Council will not be dividing the Framework into separate Lots. A sole supplier arrangement for this Framework has historically proven best value and provides for an optimum delivery solution.
