In Zuid-Holland Zuid werken 10 gemeenten, waaronder de gemeente Molenlanden, samen op het gebied van de jeugdhulp. Dit betreft het inkopen en contracteren van de regionale zorgmarkt, contractmanagement en informatievoorziening en accountmanagement. Dat wordt uitgevoerd door een kleine regieorganisatie, de Serviceorganisatie Jeugd Zuid-Holland Zuid (verder te noemen SOJ). Voor de ambulante jeugdhulpverlening was voor alle gemeenten in dit verband destijds Stichting Jeugdteams Zuid-Holland Zuid (SJT) opgericht. Voor de gemeente Molenlanden geeft SJT sindsdien dus uitvoering aan de jeugdhulpdienstverlening als onderdeel van het 'Sociaal Team'. Tot en met 2021 subsidieerden de 10 gemeenten in Zuid-Holland Zuid deze via de SOJ. Vanaf 2022 zijn alle gemeenten overgegaan tot individuele subsidieverlening.
