**II.2.4. Description of the procurement**

1) Background

l) Energy Efficiency in Buildings

Giving the great potential of energy efficiency in buildings in reducing energy consumption, improving energy access and ensuring energy security in Nigeria, the Nigerian Energy Support Programme (NESP) in its first phase (March 2013 – February 2018) conducted a baseline study on energy efficiency in buildings in Nigeria which played a role in defining core strategies in promoting energy efficiency in buildings. NESP supported with the following:

a) Building Energy Efficiency Code (BEEC): The implementation of the strategies mentioned above, led to the development of the Building Energy Efficiency Guideline (BEEG) for Nigeria, which provides information to building sector professionals on how to design and construct energy efficient buildings. The BEEG set the basis for the development of the BEEC. NESP supported the Federal Ministry of Power, Works and Housing (FMPWH) in developing the BEEC which provides building sector professionals with minimum energy requirements for new residential and office buildings in Nigeria. The code which was launched in August 2017 focuses on low cost minimum energy efficiency requirements and addresses parts of the building such as, the building envelope, window to wall ratio, roof insulation, energy efficient lighting and air conditioning. The code consists inter alia of the following elements:

— minimum energy efficiency requirements and verification methods,

— calculation methods and tools,

— building energy label and energy efficiency incentives,,

— control and enforcement, qualification of experts and review and adaptation.

b) Energy Audit in the Federal Ministry of Power, Works and Housing (FMPWH): NESP supported the FMPWH to conduct an energy audit on the Ministry's building. The recommendations of the audit carried out are currently been implemented in the building. This shows the government's commitment in promoting EE in buildings and has the potential of promoting market development of energy efficiency products and services.

In its second phase, NESP intends to support at least three (3) and a maximum of five (5) states to ensure that they are able to adopt the recommendations of the code to the design

and construction of new buildings. In addition, more energy audits of public buildings will be carried out by local energy auditors and managers who will be trained with support from NESP.

#### II) Standards for Air conditioners

NESP in its first phase supported the Standards Organisation of Nigeria (SON) to develop and implement Minimum Energy Performance Standards (MEPS) for air conditioners and a national energy efficiency label for household electrical appliances and equipment. Support towards the development of additional standards will also be provided in the second phase of the programme.

#### 2) Description of the assignment

NESP is looking for a multi-disciplinary team of international consultants to provide support to selected states in the adoption and implementation of the Nigerian Building Energy Efficiency Code (BEEC) including training and energy auditing of public buildings.

The Consultants will support NESP in providing advice to its partners – including, but not limited to FMPWH (Housing sector), the state agencies responsible for building plan approvals, professionals in the construction Industry (e.g. architects, engineers etc.)

The period of the assignment will be 16,7 months, within the period October 2018 to November 2020. The number of person days estimated for the assignment is 500, out of which 165 are field days.

#### **VI.4.3. Review procedure**

Precise information on deadline(s) for review procedures:

According to Article 160, Section 3 of the German Act Against Restraint of Competition, application for re-examination is not permissible insofar as

1) the applicant has identified the claimed infringement of the contract award regulations before submitting the application for re-examination and has not submitted a complaint to the commissioning party within a period of 10 calendar days; the expiry of the period pursuant to Article 134, Section 2 remains unaffected;

2) complaints of infringements of contract award regulations that are evident in the notice are not submitted to the commissioning party at the latest by the expiry of the deadline for the application specified in the notice or by the deadline for the submission of bids;

3) complaints of infringements of contract award regulations that first become evident in the tender documents are not submitted to the commissioning party at the latest by the expiry of the deadline for application or for the submission of bids;

4) more than 15 calendar days have elapsed after receipt of the notification from the commissioning party that it is unwilling to redress the complaint.

Sentence 1 does not apply in the case of an application to determine the invalidity of the contract in accordance with Article 135, Section 1 (2). Article 134, Section 1, Sentence 2 remains unaffected.
