In order to ensure sufficient competition, documentation of deliveries that the tenderer carried out more than 3 years ago can also be taken into consideration. the overview must include a statement of: The assignment value, dates, recipient (name, telephone and email) — A brief description of the delivery. It is the tenderer's responsibility to document relevance through the description.

2) Requirement: the tenderer must have sufficient capacity to fulfil the delivery.

Documentation requirement: a description must be given of the tenderer's technical personnel or technical entities at the tenderer's disposal for fulfilment the contract.

3) Requirement: the tenderer must have sufficient competence to implement the delivery.

Documentation requirement: a description of the education and professional qualifications of the personnel that the tenderer has at his disposal for fulfilment of the contract. CVs are not requested here.

4) Requirement: The tenderer must have a good and well-functioning quality assurance system.

Documentation requirement: a description of the tenderer's quality assurance methods. If the tenderer is certified in accordance with ISO 9001 or equivalent standards, it is sufficient to present a copy of a valid certificate.

5) Requirement: the tenderer must have a good environment management system.

Documentation requirement: A description of the environmental management measures that have been implemented in the company. If the tenderer is certified in accordance with ISO 14001 or equivalent standards, it is sufficient to present a copy of a valid certificate.
