In 2023 he was awarded the Parliamentary Literature Prize for "innovation drama and prose as a voice for the non-fiction doctor" (from the Swedish Academy's justification). Now the plan is to build a centre for dissemination of Jon Fosse's writings, at Tangerås in Strandebarm, where he grew up. The landscape here is what he refers to as his "innermost" landscape, and it plays an important role in the understanding of the artistry. The centre shall take care of and strengthen the connection between Fosse's art, New Norwegian language and the landscape in Strandebarm and facilitate new cultural expression with national and international relevance. The public shall be able to experience performing arts, music and exhibitions, at the same time as there is room for reflection with view to the fjord. The new building shall maintain high architectural quality and, in collaboration with the landscape, mirror Fosse's artistry, while contributing to a rich and diverse cultural life.
