Norwegian tenderers shall present a 'TAX and VAT certificate'. The tax certificate can be ordered from Altinn, and it must not be older than 6 months calculated from the deadline for submitting a request for participation in the competition or a tender.

'Qualification Requirement:

Tenderers must be registered in a company register, professional register or a trade register in the country where the tenderer is established.

Documentation requirement:

- Foreign companies: Verification that the tenderer is registered in a company register, professional register or a commerce register in the country where the tenderer is established'.

Creditworthiness with no requirement for guarantees will be sufficient to meet the requirement.

- Dealing with deviations and claims
- The process from the receiving and registration of orders until a completed delivery to the customer'.

'Qualification Requirement:

Tenderers must have an established environmental management system.

Documentation requirement:

Tenderers must submit documentation of their environment management system. The following documentation will be accepted:

- Valid attestation/certificates issued by independent bodies (e.g. ISO 14001, EMAS, Miljøfyrtårn or equivalent systems), or
- A description of the tenderer's own environmental management system. The description must, as a minimum, include environmental goals and an environmental policy'.
