Objective and scope of the procurement

The tender contest concerns a framework agreement for the procurement of water treatment chemicals (Precipitants and polymers), for chemical treatment of wastewater at six wastewater treatment plants associated with the operational assistance in Follo.

The value of the procurement is estimated to be: NOK 5,000,000 excluding VAT a year. The maximum value for the entire agreement period, including any options and expected price increase is: NOK 25,000,000 excluding VAT. The need is uncertain. If you have submitted a tax certificate and it is still valid at the tender submission deadline for this contest, you are not obliged to submit a certificate now.
