Reason for modification: Need for modifications because of circumstances which a diligent buyer could not predict.

Description: Recientemente se ha identificado un incremento significativo en las necesidades reales de material de medicina y fisioterapia respecto a las previsiones recogidas en el expediente de licitación. Dicho incremento responde a la necesidad de reposición de material existente que presenta un elevado grado de desgaste, deterioro u obsolescencia, derivado del uso propio de la actividad asistencial. Si bien ya se ha publicado el expediente 030-2026-0070 para garantizar el suministro de material para medicina y fisioterapia, hasta la adjudicación del nuevo contrato resulta imprescindible proceder a la modificación del contrato vigente. Debe tenerse en cuenta que la actividad de los centros es esencialmente asistencial, por lo que la disponibilidad de estos materiales resulta crítica para asegurar la correcta prestación del servicio. La ausencia de material afectaría gravemente a la operatividad de los centros y

comprometería la atención sanitaria. Asimismo, el incremento de necesidades responde a circunstancias sobrevenidas e imprevisibles en el momento de licitar. La modificación del contrato resulta necesaria para asegurar la continuidad de la actividad asistencial.
