It must be possible to import data (RegTop) from the current route planning system to a new system.

The system should have the flexibility to manage route data, where you also can inform users that single tours are booked tours. Great flexibility will be required of the supplier and the system as the contracting authority requires that the delivered systems should result in increased mobility for the County's inhabitants and other visitors.

Tenderers must submit tenders for the delivery of an adequate system and a separate service and maintenance agreement.

The Tenderer is obliged to cooperate and relate to the at any time prevailing contracts that the contracting authority has with other suppliers. The tenderer may be required to make direct

contact with other suppliers or collaborating partners of the contracting authority (other management companies, ticket system suppliers, EnTur, real-time suppliers, etc. The list is not exhaustive.)

The estimated value of the contract is NOK 5 500 000, including a service agreement for 10 years. The estimated value is not binding for the contracting authority.
