Other justification: Naručitelj je u EOJN RH, dana 15.03.2024. godine, pod brojem objave 2024 /S F02-0002202, objavio otvoreni postupak javne nabave za predmet nabave „Usluga preuzimanja i zbrinjavanja miješanog komunalnog otpada KBO 20 03 01“, za zbrinjavanje 4.200 toma miješanog komunalnog otpada. S obzirom da u prethodnom otvorenom postupku nabave nije zaprimljena niti jedna ponuda, naručitelj je dana 23.04.2024. godine temeljem članka 298., 303. i 308. Zakona o javnoj nabavi (NN 120/16 i 114/22)navedeni postupak poništio. Naručitelj je u EOJN RH, dana 28.07.2025. godine, pod brojem objave 2025/S F02-0008822, za isti predmet nabave ponovio otvoreni postupak javne nabave uz mogućnost

nuđenja usluge preuzimanja i zbrinjavanja miješanog komunalnog otpada po grupama predmeta nabave, S obzirom da niti u ponovljenom otvorenom postupku nabave nije zaprimljena niti jedna ponuda, naručitelj je dana 09.09.2025. godine, temeljem članka 298., 303. i 308. Zakona o javnoj nabavi (NN 120/16 i 114/22) ponovljeni postupak poništio. Slijedom navedenog, naručitelj na osnovu članka 131. stavak 1. ZJN 2016 pokreće pregovarački postupak bez prethodne objave poziva na nadmetanje, obzirom da uvjeti u Dokumentaciji o nabavi u ovom Pregovaračkom postupku nisu bitno izmijenjeni u odnosu na uvjete iz prethodno objavljenih postupaka, čime su ispunjene zakonske pretpostavke za primjenu ovog postupka. Naručitelj mijenja procijenjenu vrijednost nabave ovog postupka, obzirom da je analizom tržišta utvrdio da početno procijenjena vrijednost ne odgovara trenutnim tržišnim okolnostima. Naručitelj u ovom pregovaračkom postupku bez objavljivanja javnog poziva provodi postupak za zbrinjavanje 1.000,00 tona miješanog komunalnog otpada.
