II.1.5. Short description of the contract or purchase(s)

Horsens Byråd har besluttet, at alle ejendomme i Horsens by og omegn senest i 2030 skal have fjernvarme. De cirka 10 000 ejendomme, der i dag bliver opvarmet med naturgas eller olie, skal have installeret fjernvarme.

Planen indebærer, at der bygges et nyt varmeværk (biomasseanlæg) ved siden af det eksisterende kraftvarmeværk på Horsens Havn. Og for at få varmen ud til de 10 000 nye kunder, skal der lægges 214 kilometer nye fjernvarmeledninger ud.

Fjernvarme Horsens har, med baggrund i Byrådets beslutning, indsendt og fået godkendte et samlet projektforslag for fjernvarmeforsyning af de gasforsynede områder i Horsens By. Vi forventer, at kunne realisere hovedparten af planen indenfor de kommende 5 år. Dette vil stille store krav til vores samarbejdspartnere omkring organisering, kapacitet og kvalitet.

Anlægsarbejde vil dels bestå af et mindre antal forsyningsledninger på ca. 25 km trace i DN150 — DN300 samt et stort antal distributionsnet på i alt ca. 200 km trace i DN40 — DN250 og med mange kundetilslutninger.

Denne rammeaftale og tilhørende kontrakter omfatter el- og smedearbejder i forbindelse med etablering af vekslerstationer, ved realisering af Fjernvarmeplan Horsens.
