VI.4.3. Review procedure

Precise information on deadline(s) for review procedures:

NB: le président du tribunal de 1re instance de l'arrondissement judiciaire concerné peut également statuer au provisoire (article 584 du code judiciaire).

Ce tribunal est seul compétent pour les contestations au fond portant sur un droit civil (ex: octroi de dommages-intérêts...). Le président doit être saisi le plus rapidement possible et le tribunal, dans un délai de 5 ans (article 2262 bis du code civil).
