Description: Etelä-Savon hyvinvointialue Eloisa pyytää tarjouksia oikeudellisista asiantuntijapalveluista tämän tarjouspyynnön ja sen liitteiden mukaisesti. Hankittaviin oikeudellisiin asiantuntijapalveluihin kuuluvat asiakirjojen laadinta, kommentointi-, neuvonta- ja ohjauspalvelut. Neuvonta- ja ohjauspalvelujen toteutus tapahtuu pääosin puhelimitse, sähköpostitse, muulla sähköisellä etäyhteydellä tai tilaajan luona. Oikeudellinen asiantuntijapalvelu kohdistuu julkisoikeudellisen yhteisön oikeudellisiin kysymyksiin. Palvelua tilaavat tilaajan eri yksiköt tarpeidensa mukaan. Hankintaan ei sisälly oikeudenkäyntiasiamiespalvelut ja muut oikeudelliset palvelut, joihin ei sovelleta hankintalakia.

Main features of the procedure: Kyseessä on hankintalain (1397/2016) luvun 12 ja liitteen E kohdan 8) mukainen muu erityinen palveluhankinta (CPV-koodi 79100000 Oikeudelliset palvelut). Hankintamenettelynä on hankintalain 32 §:n mukainen avoin menettely sovellettuuna hankintalain 12 luvun mukaiseen muuhun erityiseen palveluhankintaan. Avoimessa menettelyssä hankintayksikkö julkaisee hankintailmoituksen ja asettaa saataville tarjouspyynnön, joiden perusteella kaikki halukkaat tarjoajat voivat tehdä tarjouksen. Avoimella menettelyllä perustetaan osa-aluekohtainen toimittajarekisteri. Toimittajarekisteri on muulle erityiselle palveluhankinnalle luotu oma menettely, jossa noudatetaan hankintalain luvun 12 säännöksiä. Tarjousten määräajan päättymisen jälkeen hankintayksikkö avaa tarjoukset ja ennen tarjousten valintaa hankintayksikkö tarkistaa, että seuraavat edellytykset täyttyvät: 1) tarjous on hankintailmoituksessa ja hankinta-asiakirjoissa asetettujen vaatimusten, ehtojen ja perusteiden mukainen; 2) tarjouksen on antanut tarjoaja, jota ei ole suljettu menettelyn ulkopuolelle 80 tai 81 §:n nojalla, ja joka täyttää hankintayksikön asettamat soveltuvuusvaatimukset. Avoimessa menettelyssä hankintayksikkö voi tarkistaa tarjousten vaatimustenmukaisuuden ja vertailla tarjoukset ennen yllä mainittua 2) kohdassa tarkoitettua tarkistamista. Hankintasopimusta ei kuitenkaan voida tehdä sellaisen tarjoajan kanssa, joka olisi tullut sulkea menettelystä 80 §:n nojalla tai joka ei täytä hankintayksikön asettamia soveltuvuusvaatimuksia. Hankintayksikkö voi myös milloin tahansa hankintamenettelyn aikana pyytää tarjoajia toimittamaan kaikki tai osan selvityksistä sen tutkimiseksi, koskeeko tarjoajaa

80 §:ssä tarkoitettu pakollinen poissulkemisperuste tai 81 §:ssä tarkoitettu harkinnanvarainen poissulkemisperuste ja täyttyvätkö hankintayksikön asettamat soveltuvuusvaatimukset, jos se on tarpeen menettelyn asianmukaisen kulun varmistamiseksi. Toimittajarekisteriin valitaan viisi parhaimmat pisteet saanutta toimittajaa/osa-alue ellei soveltuvuusvaatimukset täyttäviä ja tarjouspyynnön mukaisia tarjouksia ole vähemmän. Toimittajarekisterin etusijajärjestys muodostetaan osa-aluekohtaisesti parhaalla hinta-laatusuhteella siten, että osa-alueella parhaat hinta-laatusuhteet saanut tarjonnut tarjoaja saa etusijajärjestyksen 1. ja toiseksi parhaimmat pisteet saanut tarjoaja etusijajärjestyksen 2. ja niin edelleen. Palvelun tilaukset sopimuskaudella tehdään tarjouspyynnön liitteenä olevassa hankintasopimusluonnoksessa kuvatun mukaisesti.
