The Ministry of Foreign Affairs has entered into a contract with Radisson BLU Plaza Hotel for hotel services for the NATO foreign minister meeting that will take place at the turn of the month May-June 2023 in Oslo. The procurement was deemed to be exempt from a notice obligation in accordance with the PPR § 13-4 letter b, second paragraph, cf. the PPR § 8-17, fifth paragraph, letter b.

The Ministry of Foreign Affairs needs to procure hotel services for the NATO foreign minister meeting that will take place at the turn of the month May-June 2023 in Oslo. The hotel must be closed to other guests in the period 30 May to 1 June, as well as possibly several days before and after the meeting. There is currently a need to take over all the meeting rooms for rigging up on 29 or 28 May. The contract will primarily cover, amongst other things, needs connected to accommodation for visitors and police, breakfast, meeting activities for NATO, bilateral meetings, etc.

Explanation:

Reason for awarding a contract with a prior notice: The assessment was that the notice obligation did not apply for this procurement, as the terms in the PPR § 13-4 letter b, second paragraph were fulfilled, cf. the PPR § 8-17, 1st paragraph, letter b. In this case the contracting authority assessed that the required service is of such a character and nature that it, due to technical reasons, can only be provided by one supplier. This is justified partly on the basis of location as regards which locations it is possible to secure properly (by police and other security authorities), and on capacity as regards which locations actually have the required capacity to receive all the visitors for the NATO meeting.

Radisson BLU Plaza Hotel is the only location that fulfils the absolute security requirements for the meeting, which also fulfils the required capacity needs. In cases such as this, where there is only one supplier that can provide the service, it is clear that a contest notice would not give better competition. A notice in such cases would also go against the aim of the rules to promote efficient use of society's resources, cf. PPA, section 1.
