### IV.1. Description

#### IV.1.1. Type of procedure

Explanation:

De behoefte aan de wijziging komt voort uit de toetreding van de gemeente Velsen tot de gemeenschappelijke regeling. De consequentie hiervan is dat werkzaamheden vanaf dan worden uitgevoerd door BSGR overeenkomstig de werkwijze en werkprocessen van de aanbestedende dienst. Voor een soepele overgang, voorspoedige samenwerking en efficiënte bedrijfsvoering is een eenduidige werkwijze van groot belang. In dit kader heeft de aanbestedende dienst de raamovereenkomst gewijzigd en uitgebreid.

De aanbestedende dienst heeft in 2019 de oorspronkelijke Europese openbare aanbestedingsprocedure zorgvuldig voorbereid. Op het moment van publiceren van de aankondiging van de oorspronkelijke overheidsopdracht was het niet duidelijk of de gemeente Velsen zou toetreden. Pas in 2020 werd duidelijk dat Velsen zou toetreden.

Daarnaast is de aanvulling van de overheidsopdracht noodzakelijk gezien de werklust en de krapte in de arbeidsmarkt waardoor het werven van personeel moeizaam verloopt. Uit de door de aanbestedende dienst zorgvuldig opgestelde raming is gebleken dat de wijziging onder 50% van de oorspronkelijke opdrachtwaarde blijft.

Er is sprake van een toegestane wijziging indien sprake is van onvoorziene omstandigheden. De aard van de werkzaamheden (inhuur personeel middels detachering voor WOZ-taxaties woningen en niet woningen, juridische afhandelingen WOZ bezwaren,

kwijtscheldingsverzoeken en beroepschriften, dataverwerking en deurwaardersdiensten) en de overheidsopdracht wordt niet gewijzigd. Er worden dan ook geen materiële wijzigingen aangebracht in de werkzaamheden van de huidige partners.
