Procurement of tracking devices for minor equipment to The Norwegian National Rail Administration's fleet management system for railway vehicles and other track using equipment. The system uses GPS tracking where positions are transferred via The Norwegian National Rail Administration's own GSM network to a central connection point.

The system shall now be further expanded to safeguard the overview and positions to other machinery, and a reporting unit is required for this.

The software shall be described in the tender and it must be able to be configured from the Norwegian National Rail Administration's operators as follows:

- o Adjust time intervals for data sending;
- o Adjust time intervals for data sampling;
- o Have a function for Geo-fence and the accompanying alarms;
- o Adjust the number of collections per sending;
- o Adjust GPS timeout;
- o Adjust timeout for sending.

The receiver/sender must be able to communicate via GSM (all band widths), possibly also other band widths.

Temperature area: -40 C / +60.

Precision of position: Less than 10 metres.
