- c) Construction of a new 3 storey extension to the existing Garda Station building with a level link to the existing building, forming the new external courtyard, on main Garda barracks' site;
- d) Construction of a new proposed standalone building on the PSSB site.

Construction of a new Defence Forces facility on a separate site in the Portlaoise area is part of the overall project (works currently underway)..

There will be demolition, construction and refurbishment works to buildings within the existing Garda Station and 'PSSB' site. Both the Garda Station development and Defence Forces facility development will be progressed through a phased process (refer to drawing No.1 Site Plan-Existing Structures).

The development of the new Defence Force's facility is part of this project (Note: The contract has been awarded for this project and the works have commenced). The entire project will progress as two inter-related and dependent sub-projects. One project team will have responsibility for the entire project and will be involved throughout all project phases.

The development works will consist of:

- a) Demolition to existing buildings to 2 storey office block, detention facilities, out-buildings and PSSB building at the rear of the Garda Station.

- b) A refurbishment of the existing 2 storey Garda Station building on the Garda barracks' site in Portlaoise;
 - c) Construction of a new 3 storey extension to the existing Garda Station building with a level link to the existing building, forming the new external courtyard, on main Garda barracks' site;
 - d) Construction of a new proposed standalone building on the PSSB site.
 - e) Construction of a new Defence Forces facility in Portlaoise area (separate contract).
- The existing main Garda Station building is positioned centrally on the site. It is surrounded by the historic high army barracks' walls with attached guard houses, entrance gate, 4 no. projecting defensive corners, one and two-storey contemporary additions.
