Er wordt een onderscheid gemaakt in reguliere verhuisactiviteiten en projectverhuizingen. Reguliere verhuizingen: Verhuizingen van los inventaris (tot ca. vier werkplekken). Deze verhuisbewegingen worden gebundeld en vinden in principe wekelijks (ca. 50 weken per jaar) plaats.
