Title: Vankiterveydenhuollon yksikön (VTH) työnohjauspalvelut 2026-2028

Description: Vankiterveydenhuollon yksikkö pyytää tarjouksia työnohjauspalveluiden hankintaan tämän tarjouspyynnön mukaisesti. Hankinnan kohde ja sitä koskevat vaatimukset on kuvattu tässä tarjouspyynnössä sekä hankinnan asiakirjoissa ja sopimusluonnoksessa. Palvelu on jaettu yhteentoista (11) osa-alueeseen maantieteellisen sijainnin tai ammattiryhmän (esim. psykologit ja sosiaalityöntekijät) perusteella. Hankinnan osa-aluekohtainen laajuus on kuvattu liitteessä 7. Toimipaikat ja käyttömäärät. Valituksi voi tulla yhteen tai useampaan osa-alueeseen. Sopimukset tehdään osa-alue kohtaisesti. Sopimus alkaa sopimuksen allekirjoittamisesta. Sopimus on voimassa määräaikaisena kaksi (2) vuotta. Tilaaja varaa oikeuden kahteen (2) yhden (1) vuoden mittaiseen optiokauteen. Hankinnan ennakoitu arvo on noin 220 000 euroa alv 0%. Ennakoidun arvon laskennan perusteena on huomioitu hankinnan arvioidut kustannukset neljältä (4) vuodelta. Ennakoitu arvo on sitoumukseton arvio. Sopimukseen ei sisälly määräostovelvoitetta. Ennakoidut arvot osa-alue kohtaisesti on esitetty tarkemmin liitteessä 1. Hankinnan kohde ja vähimmäisvaatimukset.

Tarkastaa tarjoajien soveltuvuutta koskevat vastaukset ESPD-lomakkeen tiedoista ja tarjoustiedoista 3. Tarkastaa tarjousten tarjouspyynnön mukaisuuden ja vertaa tarjoukset 4. Valitsee parhaat tarjoukset 5. Tekee hankintapäätökset ja antaa päätökset tiedoksi kaikille tarjoajille sekä pyytää ja tarkastaa soveltuvuutta koskevat todistukset ja selvitykset 6. Solmii hankintasopimukset voittajien kanssa Hankintasopimus syntyy vasta kirjallisen sopimuksen allekirjoittamisella. EU-kynnysarvon ylittävässä hankinnassa hankintasopimus voidaan tehdä aikaisintaan 14 päivän kuluttua siitä, kun tarjoaja on saanut tai hänen katsotaan saaneen päätös perusteluineen tiedoksi. Tilaaja voi keskeyttää hankintamenettelyn osittain tai kokonaan todellisesta ja perustellusta syystä. Tarjouksen tekemisestä, esittelystä tai muusta menettelyyn osallistumisesta ei makseta tarjoajille korvausta. Tarjousasiakirjat ovat saatavissa suomen kielellä.
