Alternatively, the Council may, if it chooses, re-open competition for that lot under the Framework, adhering to the Public Contracts Regulations 2015 for re-opening competition. The further competition will be run by inviting all successful Contractors to complete a further competition tender document, which will then be evaluated by officers using the same criteria as used to establish the Framework Agreement.
