interventions ranging from prevention and early intervention work for low levels of abusive behaviour such as non-violent aggression and controlling behaviour, right through to engaging with perpetrators who have patterns of repeat offending. The aim is to prevent the abusive behaviour escalating and/or reduce the risk posed to whilst increasing the safety of victims and their children.
