Description: Större reinvesteringsobjekt Lundbytunneln Lundbytunneln är en 2060 meter lång bergtunnel och är en del av E6.21 Lundbyleden på Hisingen i Göteborg. Tunneln öppnades för trafik 1998 och är hårt belastad med cirka 50 000 fordon per dygn. Tunneln består av två parallella tunnelrör med två körfält i vardera riktningen. Lundbyleden, där Lundbytunneln utgör en del, ingår i det nationella stamvägnätet och är en väg av riksintresse samt ingår i strategiskt vägnät för tyngre transporter. Under 2026–2028 planeras omfattande underhåll och investeringar till följd av vattenin-trängning och bristande skyddskonstruktioner. Arbetet kräver längre avstängningar, cirka ett år per tunnelrör, vilket medför betydande trafikpåverkan. Samordning av åtgärder prioriteras för att minimera störningarna. Arbetena utförs som flera entreprenader.
