Voor de vervanging van de bestaande Van Briernoordbrug worden berekeningen en ontwerpen gemaakt voor een nieuwe Westboog, het renoveren van de oude Westboog ter vervanging van de bestaande Oostboog en het herberekenen van de bestaande onderbouw. Beide ontwerpen van de bogen zijn geen standaard werk door de vele beperkende randvoorwaarden waar binnen ontworpen dient te worden, en het feit dat de normen vaak niet duidelijk of toereikend zijn in het geval van hergebruik van een bestaande brug. De bestaande onderbouw is een samengesteld geheel bestaande uit een caisson (gebouwd rondom 1960)

en pijlerfundering (gebouwd in 1990), de herberekening hiervan past niet in de reguliere normen en is daardoor zeer complex.
