Kristianstads Teater ligger som en festlig krok mitt i Tivoliparken. Den invigdes i september 1906. Stilen går i vacker jugendbarock och är ritad av arkitekten Axel Anderberg, som även ritat Operan och Oscarsteatern i Stockholm.

Salongens inredning i rött, guld och grönt tillsammans med plafondmålningen av Nils Asplund är väl bevarad från tidens tand. Teatern är en av de äldsta i landet som är i bruk.

Nu planeras en uppfräschning av salongen och de gamla stolarna ska bytas ut. Sammanlagt handlar det om 277 st. nya stolar fördelat på en parkett och 2 balkonger. Vid upphandlingen läggs det stor vikt på kvalitet och det är av största vikt att produkten bevarar känslan som finns i den gamla lokalen på ett bra sätt.

Omfattningen gäller köp, leverans och montering av stolarna.

Brukaren kommer att riva befintliga teaterstolar innan detta åtagande påbörjas på plats.

Projektgenomgång/visning av objektet kommer att utföras och är obligatorisk för anbudsgivare.
