The objection is examined by the Objections Committee, which submits a recommendation to the Employer's Board of Directors, which issues its relevant decision no later than five (5) working days before the tender is held. b) Against the conduct of the competition up to and including the award decision, within a period of three (3) working days, after the interested candidate became aware of the relevant act or omission of the Employer. This objection is mandatory notified by the objector, within two (2) days from its submission, to the party against whom it is directed. The objection is examined by the Objections Committee, which submits a recommendation to the Board of Directors of the Employer and the Board of Directors issues its relevant decision no later than ten (10) working days from the submission of the objection. c) Against the award decision, regarding the legality and completeness of the award supporting documents, within a period of three (3) working days, after the interested candidate became aware of the above award decision and the above supporting documents. This objection is mandatory notified by the objector, within two (2) days of its submission to the temporary contractor or the candidate(s) against whom it is/are directed. The objection is examined by the Objections Committee which

submits a recommendation to the Employer's Board of Directors and the Board - following a recommendation from the Objections Committee - issues its relevant decision no later than ten (10) working days from the expiry of the above three-day deadline. Objections submitted for any other reasons, other than those mentioned above, are not accepted and are rejected. The relevant decision of the Board of Directors on the objection and the minutes of the Objections Committee are notified to the objectors via email, in order for them to be aware of their content. Any issue not mentioned in this Declaration is regulated by applicable legislation.
