Tähän kilpailutukseen sisältyy myös hankinnan kohteena olevan tuotteen mahdollinen kotijakelu Etelä-Pohjanmaan hyvinvointialueen osalta. Kanta-Hämeen ja Pirkanmaan hyvinvointialueet eivät tule ottamaan kotijakelua käyttöön.
