Reason for modification: Need for additional works, services or supplies by the original contractor.

Description: The Board, for crucial continuity and proper use of the Enterprise Information Management System software for the management and control of all documentation and information associated with the construction of the new children's hospital, requires Convergent to continue to perform the specified services under the contract to match the extended programme for the delivery of the New Children's Hospital.

#### 7.1.1. Change

Description of modifications: In March 2017, the Board awarded the Contract to Convergent for a period of up to 72 months. The contract was extended to June 2026 and due to the unanticipated prolongation of the project, the Board took the view that it was justified in relying on the provisions of Article 72(1)(b) as a change in provider would as a minimum lead to significant technical and economic inconvenience and disruption to the existing document management system and would expose the project to further delay/risk and the likely loss of specific know-how, tools and means which only the current provider has gained. Due to the extended programme for the delivery of the New Children's Hospital, the Board is of the view that it is justified to rely on the provisions of Article 72(1)(b) to further extend the term of the contract to match the extended construction period on the same basis.
