#### **Explanation:**

Het huidige ICT Beheer contract is op 01-06-2020 verlengd met de huidige leverancier Brunel. De huidige overeenkomst had geen mogelijkheid tot verlenging en had Europees aanbesteed moeten worden. Echter is dit niet gedaan. De reden van deze verlenging is dat er geen aanbestedingsprocedure opgestart kon worden aangezien RSG Wolfsbos te maken had met de Covid-19 pandemie. Op het moment dat de overeenkomst was verlopen werkten de medewerkers en leerlingen van RSG Wolfsbos grotendeels thuis. Gezien de prioriteit van een goed werkende ICT omgeving heeft RSG Wolfsbos destijds besloten om de overeenkomst met Brunel te verlengen om zodoende de continuïteit van het onderwijs niet in het geding te laten komen.

Inmiddels is er een start gemaakt met de voorbereidingen voor een aanbestedingsprocedure. verwachting is dat deze in oktober/november gepubliceerd gaat worden.
