This tool helps to identify reporting mistakes, benchmark programme and Member State performance, and identify thematic investment, thereby enabling Desk Officers in DG REGIO to make informed decisions on the investment strategy, quality of the data and performance of the programmes. In 2022, the scorecards were extended to cover 2021-2027 programmes under negotiation, in order to provide assistance to Directorate-General REGIO in the assessment of investment strategies and indicator systems.
