Justification for the duration of the framework agreement: The procurement includes a framework agreement for operational services (CLS Agreement) for 10 years. This length corresponds to the lifetime of the meteorological sounding system. Radiosondes, training courses and software updates will be adapted to the specific system, and the need for these services will persist throughout the system's lifetime. It will therefore not be suitable to have different suppliers for the delivery of the meteorological sounding system and its operational services. If the framework agreement were to be subject to competition, the sounding system also have to be replaced. This would be a cost-inefficient solution as the sounding system has a lifetime of 6 years longer than the limit of 4. Based on this, the framework agreement is set to a length of more than four years.
