The existing vehicle shall collect and deliver from suppliers. Both vehicles shall be ready for production when delivered to the contracting authority. After the tenderer has been chosen, the contracting authority shall participate in the final formulation of the systems in order to quality assure the process. Any changes that involve this shall be priced in the tender (total package (fittings and assembly)). The contracting authority will meet at the actual building location or participate digitally. Both vehicles shall have the same technical system and they shall be fulfilled the following: Camera equipment shall be identical in both vehicles. The equipment shall be used parallel to both vehicles and shall be able to move between the vehicles when needed. The systems shall have the same user interface and software.
