Folktandvården Skåne AB har genomfört en upphandling av Dentalinredning för tandvårdskliniker, enligt lagen (2016:1145) om offentlig upphandling (LOU), genom öppet förfarande. Upphandlingen annonserades den 2026-04-24 i Mercell TendSign, där upphandlingsdokumenten funnits tillgängliga. Sista dag för anbud var 2026-05-28. Vid anbudstidens utgång hade endast ett (1) anbud inkommit. Mot bakgrund av det begränsade anbudsutfallet bedömer Folktandvården Skåne AB att konkurrensen i upphandlingen varit otillräcklig. Enligt rättspraxis utgör bristande konkurrens ett sakligt godtagbart skäl för att avbryta en upphandling (se bl.a. EU-domstolens dom i mål C-27/98 Fracasso och Leitschutz samt Högsta förvaltningsdomstolens avgörande RÅ 2008 ref. 35). Beslutet att avbryta upphandlingen är i sin helhet förenligt med de grundläggande upphandlingsrättsliga principerna, utifrån bristande konkurrens, då avbrytande av upphandlingen får ske om endast en leverantör återstår efter leverantörskvalificeringen.
