Dado que el colectivo policial presta servicios con uniformidad reglamentada en base a la normativa específica de los cuerpos de Policía Local, con el deterioro de las mismas por el transcurso del tiempo, es necesario la dotación a los integrantes de la plantilla de dicha uniformidad policial mediante el suministro de las mismas por empresas especializadas que cumplen con los requisitos normativos de dichas prendas específicas y regladas, adaptándose las mismas a la normativa vigente, por lo que se estima conveniente que por el Ayuntamiento se proceda a celebrar contrato de suministro.
