The first qualification round will last for 30 days. The Directorate of Digitalisation cannot, therefore, start to hold contests under the system for 30 days when we have assessed all the applications for inclusion that have been received by the deadline.

Between NOK 3- NOK 4 million excluding VAT over 4 years. The value is subject to change as Digdir is a newly established directorate. The estimated value is based on figures obtained from the previous 'Difi' and 'Altinn'. The amount procured will nevertheless depend on budget grants.
