Obligatory independent inspections were implemented in construction cases effect from 1.1.2013, cf. the Building and Planning Act (pbl) § 24-1 and § 24-2. The contracting authority has, therefore, a need for the independent inspection of execution function (building physics, construction safety and geotechniques). The framework agreement shall see to the need for this type of service. The framework agreement shall also cover inspection of other inspection areas, in addition to those legally imposed, where required by the building authorities. In this event this will be further described in each individual assignment.
