For those businesses with less than 10 staff, individual business cases may be put forward if they have high growth potential for them to be considered for the programme.

The successful suppliers will be expected to deliver high quality training/development across Greater Manchester. These suppliers will form part of a framework of providers and will be called-off by the Hub to work with named executives from eligible businesses.

For each commission, suppliers will be required to design and deliver 12 hours of intensive support on specific leadership areas. All 12 hours of delivery must be face to face regardless of delivery style chosen. The support must be able to be delivered either entirely on a one to one basis, a blend of one to one and internal group of executives or a blend of one to one and external group of mixed business executives, and be flexible and tailored to meet the specific needs of an individual business.

Each 12 hours of support per individual business is paid at a maximum of 1 000 GBP exc. VAT
