The objective is to increase energy efficiency levels in 15 municipalities by (i) upgrading 77 buildings (i.e., installation of remote management systems, replacement of gas/diesel boilers for HVAC system and/or biomass DH, lighting systems in buildings, and electrical switch off, installation of PV systems in 16 building to create energy communities,), (ii) installing 12 new biomass DH, and (iii) street lighting retrofit.
