The service will be considered for all Blackburn with Darwen residents who have suffered an acute trauma or illness which has resulted in a need for therapy and where this cannot be delivered in a person's own home. The service will empower service users to recover from episodes of ill health and to return home through the provision of individualised support and therapy, care and well-being, medical oversight and nursing, where applicable. The service is designed to optimise an individual's level of independence based on identified needs and in accordance with the agreed care plans. Rehabilitation is described by the World Health Organisation as 'an active process by which those disabled by injury/disease achieve a full recovery, or if a full recovery is not possible, realise their optimal physical, mental and social potential and are integrated into the most appropriate environment'.
