Justification for the accelerated procedure: Naročnik določa skrajni rok za prejem ponudb v trajanju 15 dni na podlagi četrtega odstavka 40. člena ZJN-3. Skrajšanje roka je nujno zaradi zagotovitve neprekinjenega servisiranja vozil, strojev in naprav, ki so ključni za varno in nemoteno izvajanje javnih nalog naročnika. Nujnost postopka izhaja iz objektivne potrebe po čimprejšnji sklenitvi pogodb. S tem naročnik implementira priporočila Računskega sodišča RS, ki jih je dobil v postopku revizije poslovanja glede celovitega javnega naročila za servisiranje različnih vrst vozil, strojev in naprav ter dobavo rezervnih delov. Zaradi različnih datumov izteka obstoječih pogodb bi vztrajanje pri rednem 30 dnevnom roku povzročilo pravni vakum pri vzdrževanju opreme, kar bi neposredno ogrozilo varnost uporabnikov in povzročilo nesorazmerne stroške pri interventnem premoščanju potreb. Naročnik je pri določitvi 15 dnevnega roka upošteval 74. člen ZJN-3 in ocenil, da je rok glede na naravo predmeta (standardne servisne storitve) primeren in sorazmeren.
