The Fast Air Support Team (FAST), part of the UK Ministry of Defence (the MOD), intends to place a 1-year contract, with an option to extend for a further 6-12 months, with Martin Baker Aircraft Company Ltd for the provision of crew escape systems support (supply of spares for ejector seats: FAST/00242). The contract has an estimated value of 5 000 000,00 GBP.
