Ces achats de plants sont réalisés dans le cadre du plan de relance économique annoncé par le Gouvernement (France Nation Verte) pour faire face aux conséquences de la crise sanitaire et climatique dans les forêts situées sur le territoire de la Direction Territoriale Grand-Est. *Plants en godets : Il s'agit de plants livrés avec le conteneur qui a servi pour l'élevage des plants en pépinière. Plants en mottes : les plants sont extraits du conteneur qui a servi pour l'élevage en pépinière et les mottes constituées du système racinaire et du substrat sont conditionnées dans des contenants pour le transport (généralement cagettes en bois).

Justification for the accelerated procedure: Conformément à l'article R.2161-3 du Code de la commande publique, le délai de réception des offres peut être réduit en cas d'urgence dûment justifiée. Cette urgence est caractérisée par la nécessité de disposer des plants dans des délais compatibles avec la campagne de plantation, dont le calendrier est strictement contraint par des considérations techniques et agronomiques. En effet, les plantations réalisées à l'automne présentent un taux de reprise significativement supérieur, notamment pour les plants en godets, conditionnant ainsi la réussite des opérations. Cette situation d'urgence résulte de circonstances extérieures au pouvoir adjudicateur et non imputables à celui-ci, parmi lesquelles : -le caractère tardif et variable des retours des communes forestières et autres propriétaires concernant l'expression de leurs besoins, -la nécessité d'intégrer, à un stade avancé de la définition du besoin, des demandes complémentaires de regarnis destinées à compenser des pertes résultant d'aléas naturels (dégâts de gibier, nuisibles, événements climatiques ou abiotiques exceptionnels), par nature imprévisibles, et permettant d'ajuster les

quantités afin d'atteindre les objectifs de densité fixés dans le cadre de plantations subventionnées. Ces éléments n'ont pas permis d'engager la procédure de mise en concurrence dans des délais compatibles avec les délais normaux de publicité, sans que cela résulte d'un défaut d'anticipation du pouvoir adjudicateur. Dans ce contexte, la réduction du délai de réception des offres à 21 jours apparaît strictement nécessaire pour garantir la continuité et l'efficacité de l'action publique, tout en permettant le respect des exigences de mise en concurrence, les documents de la consultation étant accessibles par voie électronique dès la publication. En conséquence, il est fait application des dispositions de l'alinéa 3 de l'article R.2161-3 du Code de la commande publique.
