Service providers will be required to meet the care needs and clinical outcomes of service users in these care groups and will also need to comply with the National Minimum Standards (2003) and subsequent revisions thereof, in accordance with the Care Standards Act 2000. Any qualified provider (AQP) contracts awarded as a result of this procurement process are awarded without any exclusivity or commitment as to volumes or levels of activity on the part of the Commissioner(s).

Contracts awarded will be for a period of 3 years with an option to extend for up to a further 2 years at the discretion of the Commissioner(s).
