The report shall be based on the last known accounting figures. The date must be clearly stated. Companies without a satisfactory credit rating, recently established companies with credit rating AN, some foreign companies or companies without reporting obligation to the Brønnøysund Register Centre will not always be able to document that the requirement is fulfilled. In such cases, they will be able to compensate with a satisfactory credit rating which provides an equivalent security for implementation ability. Such alternative documentation shall be included with the tender. If the tenderer has valid reasons for not submitting the documentation requested by the contracting authority, the tenderer can prove his economic and financial position with any other document that the Contracting Authority deems suitable. The contracting authority reserves the right to obtain updated credit assessments from a publicly certified credit rating company.

Description of selection criterion: Requirement 5 - Quality Management System A good and well-functioning quality management system is required for the requested services.
