- 5 emergency shelters under the severe weather emergency protocol.

The Council wishes to secure one provider to deliver these services. The service being commissioned will be for a period of 2 years with an option of extending 1 further year. Funding is dependent on future funding settlements and successful service delivery. The successful contractor must have previous experience of delivering similar work for other local authorities and must be able to commence the service on 1.10.2019.
