Tenderers can submit tenders in both competitions if they so desire, but attention is defined that the tenderer awarded the contract for RIBr cannot be awarded a contract for UK RIBr. If the same tenderer is ranked best in both competitions, the tenderer will rank second in the competition for UK RIBr and the contract will be awarded for UK RIBr.
