Deze opdracht voor diensten heeft betrekking op de bijstand en de vertegenwoordiging in rechte van het Vlaamse Gewest (of de Vlaamse Gemeenschap) inzake juridische geschillen (als eiser of als verweerder) voor de rechtbanken en andere instanties van

geschillenbeslechting met betrekking tot geschillen waarbij de belangen van het Vlaamse Gewest (of de Vlaamse Gemeenschap) worden behartigd door VLABEL. De opdracht omvat 9 percelen. Algemene omschrijving van de percelen. De heffingsgerelateerde percelen (Perceel 1 tot en met Perceel 6) betreffen in de eerste plaats fiscale procedures voor de rechtbank van eerste aanleg en het hof van beroep omtrent de grond van de zaak. Binnen deze percelen behoren telkens ook de zaken die bij de beslagrechter worden ingeleid doch die een duidelijk en objectieve band vertonen met een geschil omtrent de grond van de zaak (vb. zelfde belastingplichtige, zelfde kohierartikel, zelfde perceel of pand, etc.) Daarnaast kunnen uitzonderlijk ook dossiers die door een belastingplichtige voor andere instanties zijn ingeleid worden toegewezen binnen deze percelen (bv. zaak die per vergissing voor de raad van state wordt ingeleid, zaak die per vergissing bij een territoriaal of materieel onbevoegde rechtbank wordt ingeleid, behandeling van zaken voor de arrondissementsrechtbank, etc.) De percelen 7 t/m. 9 betreffen allerhande betwistingen i.v.m. de inning en invordering.

Het voorwerp van deze opdracht is de raamovereenkomst tussen de opdrachtgevende overheid en de advocaten, waardoor de opdrachtgevende overheid, gedurende de looptijd van de overeenkomst, één van de advocaten waarmee de opdracht wordt gesloten, ermee kan belasten om haar in een welbepaald geschil voor de gerechtelijke instanties of andere instanties van geschillenbeslechting te vertegenwoordigen. Deze raamovereenkomst betreft dus enkel de algemene aanstelling van de advocaten en staat – onder andere wat betreft de duur – evenwel los van de afzonderlijke opdrachten (de vertegenwoordiging in rechte inzake een welbepaald geschil) die op basis ervan worden gegeven.
