It is considered that this contract can be placed using the Negotiated Procedure without Prior Publication of a Contract Notice, pursuant to Article 28(1)(e) of Directive 2009/81/EC (Regulation 16(1)(a)(ii) of the Defence and Security Public Contracts Regulations 2011). This is because of technical reasons. The CIPFA Model is well established and has been used by several Departments, and was used by the MOD in the past. Additionally, the Finance Leadership Group stated we need to use the model so they can benchmark each Department. All government departments need to be compared against each other using the same system. The system previously used by the NAO has been withdrawn and as other departments are using this model, and it would be technically impracticable to use another model. CIPFA also hold exclusive rights to the Financial Management Model that has been chosen by the FLG and are an economic operator able to satisfy this procurement requirement.
